YMCA SPORTS DRAFT POLICY

- 1) (a) A coach will automatically have his/her son or daughter.
 (b) ONE assistant coach will automatically have his/her son or daughter.
 (c) Brothers, sisters, or brothers and sisters will automatically be on the same team.
- 2) Attempts will be made to honor requests, but in no way be bound to do so.
- 3) Coaches will take turns drafting, until all teams have the same number of players.
- 4) Coaches shall pick number to see who will start the draft.
 Example: If there are 4 coaches, then the draft order will be #1,#2,#3,#4,#4,#3,#2,#1,#1,#2, etc.
- 5) Should any questions or problems arise during the draft, the Program Director will make a final decision on the matter. At the end of the season, that matter can be brought up as whether to add it to the draft rules, alter the rule, or to strike it all together.
